No bid will be accepted from foreign principals who do not have sole nominated representatives/ accredited agents in Sri Lanka.

7. All bids must accompany a bid security issued by a commercial bank operated in Sri Lanka approved by the Central Bank **amounting to Rs.672,000.00.** The validity period of the bid security shall be 119 days from the date of bid opening from **19.02.2025 up to 18.06.2025.**
